Any other persons or bodies associated with the Event and I indemnify all such parties against all actions, claims, demands and costs brought by any third party arising from and out of my participating in an Event or my presence on any land or place on which and Event is held, or to be held, and I agree that this indemnity shall endure during such period as I am the holder of a competition licence issued to me by MNZ and shall be binding on my assigns, executors and administrators.
