Motorcycling New Zealand is calling for Expression of Interest (EOI) from women riders to be a part of the New Zealand Team competing in the 2024 FIM Oceania Women's Cup to be held at the Woodville Grand Prix on Sunday 28th January 2024.

FIM Oceania/MNZ will provide limited financial and administrative support for the team, but applicants are advised that there may be some rider contribution required in 2024, confirmation of rider expenses will be advised at a later date.

Riders selected for the New Zealand team, must hold a current **New Zealand Passport and must be 15 years old or over on race day (28th January 2024).**

Each Federation (participating country) is required to present their riders and team members in National Representative Colours including Rider Uniform, Team Uniform and front plate of motorcycle.

Each Federation (participating country) will select their riders by announcement of Expression of Interests in each country. Then they will select their rider line-up from nominees who complete this Expression of Interests. The selection of riders from each country will be determined by a process arranged in each country, without consent nor approval of the other country or FIM Oceania.

There will be no entry fees for Australian riders nominated by Motorcycling Australia for Team Australia. New Zealand riders representing Motorcycling NZ for Team NZ should contact their team representative to confirm arrangements.

10. FUEL

In accordance with -

Must be Unleaded fuel available on demand from a fuel bowser at any service/petrol station in New Zealand and;

- i) No more than 100 RON,
- ii) Contain no additives other than those added at the point of manufacture except for lubricating oils for 2 - stroke machines,
- iii) Be readily available in New Zealand and,
- iv) Comply with the New Zealand government regulation - "Fuel Quality Standards Act 2011"

11. INSURANCE

By completing the nominating process noted in point 4, each Federation (participating country) certifies that all riders nominated are insured. With rider from New Zealand to be insured in accordance with the MNZ requirements and regulations, including insurance coverage for emergency medical care and emergency transport from the circuit to hospital.

Riders from outside of New Zealand, including Australian riders, must be the holder of a current FIM license, including a valid FIM World Championship or FIM Oceania CONU license, inclusive of one-event or annual license. FIM license and insurance coverage will provide emergency medical care, emergency transport from the circuit to hospital and repatriation to the rider home country – as per FIM terms & conditions.

The organizer has contracted insurance in accordance with the Motorcycling New Zealand regulations and must be the holder of a Motorcycling NZ permit.

Motorcycling New Zealand must list the event on the FIM Extranet and be issued with the FIM IMN to confirm the activation of FIM Insurance by this process.





12. PROTESTS AND APPEALS

Any person or group of persons (rider, entrant, official, etc.) concerned by a decision taken under the authority of the Clerk of Course or Officials, may ask for a protest of any such decision, in accordance with Motorcycling New Zealand Disciplinary Processes - Off Road.

Protests must be lodged according to the Motorcycling New Zealand Disciplinary Processes Off Road and the Supplementary Regulations and be accompanied by a fee of NZD\$50.00 - returnable if the protest is justified.

Protests against the eligibility of a rider, entrant or a motorcycle entered, must be made before the start of the official practice.

Any other protests must be lodged immediately after the reason for the protest is known.

Protests against results must be presented to the Clerk of Course or MNZ Steward no later than 30 minutes following the announcement of the results.

If there are costs relating to any technical tests required to prove or disprove a protest including but not limited to the cost of dismantling and reassembling machines and comparison machines, and the obtaining of comparison parts and manufacturers parts catalogues, these costs shall be borne by the unsuccessful party - as per MNZ MoMs - Off Road clause 7.2.9.

13. POINTS SCORING

FIM Oceania Women's Motocross Cup points

Points will be awarded to riders in each FIM Oceania Women's Motocross Cup race in according to the following scale:

1	points to the 1 st	7	points to the 7 th
2	points to the 2 nd	8	points to the 8 th
3	points to the 3 rd	9	points to the 9 th
4	points to the 4 th	10	points to the 10 th
5	points to the 5 th	11	points to the 11 th
6	points to the 6 th	12	points to the 12 th





The winner of the FIM Oceania Women's Motocross Cup is the Team (Country/Federation) who has obtained the least points from all the races, irrespective of the number of races each rider has completed.

Any rider not completing the race or not starting the race for any reason will automatically be allocated 12 points.

In case of ties, the points scored in the third race will determine the order of placing in the final standings.

In each race, the winner of the FIM Oceania Women's Motocross Cup obtains one point, the second two points, etc.

The final results of the FIM Oceania Women's Motocross Cup are determined as follows:

1. The Team winning the FIM Oceania Women's Motocross Cup is that which has gained the lowest total number of points after having added the six (6) races of its selected riders in the Woodville Grand Prix Senior Women's race.
2. In case of a tie, the Team whose rider has obtained the most first places in the Woodville Grand Prix Senior Women's race will be placed before the other(s).
3. If a tie still exists, then the Team whose rider has obtained the most second places will be placed before the other(s).
